



Registering an Out-of-State Vehicle in Texas

Moving to Texas or buying a vehicle titled in another state? Use this checklist to register your out-of-state vehicle through the Texas Department of Motor Vehicles (TxDMV).

QUICK ANSWER

New Texas residents must register their vehicle within 30 days of establishing Texas residency or accepting employment. A Texas safety inspection from a state-approved station is required before you can complete registration. Submit the out-of-state title, Form 130-U, proof of Texas insurance, and fees to the county tax assessor-collector.

PRINTABLE CHECKLIST

Required checklist

- ☐ **Out-of-state title (properly assigned to you, if purchased)** **REQUIRED**
The existing title from the other state. If you purchased the vehicle, it must be signed over to you.
- ☐ **Government-issued photo ID (current Texas address)** **REQUIRED**
Most states require proof of residency to register a vehicle.
- ☐ **Proof of Texas address** **REQUIRED**
Utility bill, lease agreement, or other proof of current residency.
- ☐ **Proof of insurance meeting Texas minimum requirements** **REQUIRED**
Insurance from an insurer licensed in Texas.
- ☐ **Odometer disclosure statement** **CONDITIONAL**
Required if the vehicle is under 10 years old.
- ☐ **VIN verification (may be required)** **CONDITIONAL**
Some states require a physical VIN inspection by law enforcement or a DMV inspector.
- ☐ **Safety and/or emissions inspection (if required)** **CONDITIONAL**
Check whether your state requires an inspection before registration.
- ☐ **Payment for title and registration fees** **REQUIRED**

SPECIAL REQUIREMENTS



Inspection: Yes — Texas requires an annual safety inspection. Vehicles from other states must pass a Texas safety inspection before registration.

STEP-BY-STEP PROCESS

- 1 Obtain a Texas safety inspection from a state-approved inspection station.
- 2 Submit the out-of-state title, Form 130-U, proof of Texas insurance, and inspection certificate to the county tax office.
- 3 Pay title fee (\$33), registration fee, and any applicable sales tax.
- 4 Surrender out-of-state plates upon request.

COMMON MISTAKES

- Not getting a Texas safety inspection before visiting the tax office.
- Waiting beyond 30 days after moving — late fees apply.
- Not updating your driver's license to Texas within 90 days of moving.
